## Step One

**Welcome / Sign In**

Please click on enroll now to be set up for home banking.

**Returning Members**  
On January 1, 2007 we will be adding security measures to better protect you from fraud. A one time enrollment process will be required to establish authentication questions and a confidence word so you can be confident when you login to home banking. You will have a grace period until 01/02/2008 to enroll.

## Step Three

**Enrollment**

You must now select your authentication questions and a confidence word. Each of the three drop-down menus contains eight questions and you must select and answer one from each menu. Then you must select a confidence word. These extra validations will ensure you've connected to the authorized home banking site.

**AUTHENTICATION QUESTION 1** What is the name of your first pet?

In order to complete your Enrollment, must answer a series of Authentication Questions shown to the left. There are multiple questions that are accessed with the drop down box. You select and answer all three questions.

As a final security measure, you will be asked to enter a Confidence Word. You may select any number of letters, etc for your confidence word. This word will be displayed each time you log on to Home Banking. If that word is not visible or is incorrect, notify the credit union immediately.

Click SAVE when you have finished.

## Helpful Hints

Change your password the first time you log into Home Banking.

You can also change your login from your member # to any login you choose.

Make sure you see your Confidence Word—Call the Credit Union if it is incorrect or does not exist.

Choose your Authentication questions based on your ability to recall them. The questions rotate.

If you login from a different computer, you will be prompted for answers to your Authentication questions. This is a security feature of the system.
