# **NOTICE OF ANNUAL BUSINESS MEETING**

#### NOTICE OF ELECTION

The Annual Business Meeting will include an election to fill one Board of Director position. The position is for a three-year term to begin upon conclusion of the election. An election will be conducted if there is more than one nominee as a whole for the one position to be filled.

### PROCESS FOR NOMINATIONS

A nominating committee appointed by the Board of Directors has selected one eligible nominee to present to fill the position on the board. A statement of qualifications and biographical data for the candidate nominated by the nominating committee is included with this notice.

As a member of this credit union you may nominate a candidate including yourself, who meets the eligibility requirements for holding a position on the Board of Directors and who you feel will earnestly represent and protect the interests of the credit union and its membership.

A nomination from a member must be made in the form of a petition and petition must:

\*Be filed with the Secretary of the Board of Directors on or before February 1, 2023.

\*Be signed by at least one percent of the membership (approximately 60 active members of SWOFCU).

\*Include a statement of qualifications and biographical data for the nominee.

An Official Petition form and Eligibility Requirements for the Southwest Oklahoma Federal Credit Union Board of Directors may be picked up at any branch of Southwest Oklahoma Federal Credit Union or you may call the credit union at (580) 353-0490 to request that these forms be mailed to you.

A completed petition and accompanying forms may be delivered in person, in an envelope addressed to the Secretary of the Board of Directors, at any Southwest Oklahoma Federal Credit Union branch. Or, a completed petition and accompanying forms may be mailed to: Secretary of the Board of Directors, Southwest Oklahoma Federal Credit Union, 1806 NW Liberty Ave., Lawton, OK 73507. If a petition is mailed it must be postmarked on or before February 1, 2023.
